





माननीय प्रबन्ध परिषद् द्वारा दिनांक 13.03.2018 को सम्पन्न 233वी बैठक में विश्वविद्यालय के कर्मचारियों के आश्रित छात्र/छात्राओं (University Employee Wards) को शिक्षण सत्र 2018-19 से शिक्षण शुल्क में 50 प्रतिशत छूट दिये जाने विषयक प्रस्ताव पर निम्नवत् संकल्प पारित किया गया है-

“माननीय-प्रबन्ध परिषद् द्वारा वित्त समिति की संस्तुति का अवलोकन किया गया। वित्त समिति की संस्तुति के दृष्टिगत प्रस्ताव पर विचारोपरान्त माननीय प्रबन्ध परिषद् द्वारा विश्वविद्यालय के कर्मचारियों के आश्रित छात्र/छात्राओं (University Employee Wards) को शिक्षण शुल्क में छूट प्रदान किये जाने हेतु विश्वविद्यालय के शैक्षणिक नियमावली के अध्याय-XI “Regulations For the Award of Tuition Freeship” में दिये गये प्रावधानों के अनुसार कार्यवाही किये जाने के निर्देश दिये गये।”

शैक्षणिक नियमावली के अध्याय-XI “Regulations For the Award of Tuition Freeship” का सम्बन्धित पैरा-6 निम्नवत् उद्धृत है--


6. “The sons/daughters/spouse of regular employees of the University who are in service or expired during the University services and the students belonging to SC/ST not in receipt of this concession from other agencies. shall be exempted from payment of tuition fee over and above the limit of 25%. However, other conditions as in para 4 and 5 above shall apply as in general cases”

उक्त पैरा के संदर्भित पैरा 4 व 5 निम्नवत् उद्धृत हैं--

4. “The students awarded the punishment of temporary dismissal or punishment of conduct probation will forfeit this concession”

5. “The tuition fee free concession will be applicable from the date of registration until the end of the academic year and fresh applications shall be invited every year.”

अतः माननीय प्रबन्ध परिषद् द्वारा पारित संकल्प के अनुपालन में उपरोक्तवत् उद्धृत पैरा 4 तथा 5 के आलोक में, पैरा-6 के अनुसार विश्वविद्यालय के कर्मचारियों के अर्ह आश्रित छात्र/छात्राओं (University Employee Wards) को शैक्षणिक सत्र 2018-19 से शिक्षण शुल्क में 50 प्रतिशत छूट/मुक्ति प्रदान किये जाने हेतु कुलपति महोदय ने सहर्ष स्वीकृति प्रदान की है।




