



Timeframe work to be followed to attend the complaints of various allottees of Campus

1. ESSTENTIAL COMPLAINTS: It will constitute the following:

- A. No light in the Residences
- B. Tap leaking
- C. W.C. Blockage

The above complaints shall be attended in next two working days.

2. COMPLAINTS OF MINOR NATURE:

i) Civil Work:

- A. Welding of hinges etc.
- B. Replacement of broken glass panes
- C. Replacement of cleat/blocks
- D. Replacement of tower bolts, sliding bolts and other fittings
- E. Replacement of taps
- F. Replacement of broken wire mesh

ii) Electrical Works:

- A. Replacement of switch, socket, angle holder
- B. Replacement of fan condenser
- C. Replacement of switch board/board sheet
- D. Replacement of small piece of wire

The above complaints shall be attended in 7 working days subject to the availability of the material.

3. COMPLAINTS OF MAJOR NATURE:

i) Civil:

- A. Replacement of shutters
- B. Replacement of W.C., Wash basin etc.
- C. Roof repair work
- D. Replacement of damaged floor

ii) Electrical:

- A. Replacement of wiring
- B. Replacement of DB/BDB, Main switch
- C. Replacement of sub-main, service bracket

The above complaints shall be attended within two months, if Engineer-incharge feels the necessity of the work subject to the availability of the funds and the arrangement of the agency from which the work is to be executed. All due care will be taken to complete the job, however, time of completion will be decided by Engineer-in-charge considering nature of complaint.

4. COMPLAINTS OF ADDITION/ALTERATION NATURE:

No addition/alteration work shall be done unless the Engineer feels that it is essential from the context of optimum use of the building and it is structurally and technically feasible. The work shall be executed only when the funds are available with the approval of the Vice-Chancellor. The time completion for these works shall be decided by the Engineer I/c on the basis of the nature of work.

Further, it is to state that the maintenance work is unsusceptible nature of measurement, and there is no specific yardstick for the output of the labour.
