Candidates for the admission in M. Tech 1st year Course

Candidates has to deposit the fees in two different amounts through demand draft payable at Pantnagar or Rudrapur.

- 1. Total fees is Rs. 57643/= but as you have already deposited Rs, 10000/= at UTU so **you have to prepare draft of Rs. 47643/=** (Payable to Comptroller, G.B.P.U.A.T., Pantnagar), payable at Pantnagar or Rudrapur. In case the candidate got admission but refused the admission, the fee shall be refunded with certain deductions as per University rules.
