## OFFICE ORDER

Hon'ble High Court, Nainital has passed the order dated 14.08.2023 on the Writ Petition (S/B) No. 82 of 2021 as under:

"Consequently, the present writ pettion is allowed. The impuged order dated 12.11.2020 passed by the Chancellor, G.B. Pant University of Agriculture & Technology, Pantnagar is, hereby quashed. Further the selction and appointment of respondent no. 4 on the post of Assistant Professor (Chemistry) in the Department of Chemistry is also, hereby, quashed, and a writ of mandamus is being issued to the respondent University to forthwith appoint the petitioner on the post of Assistant Professor (chemistry) in the Department of Chemistry, after taking into consideration the fact that the petitioner is the next candidate, who was recommended for selection. The petitioner shall be granted seniority notionally from the date of appointment of respondent no. 4 and shall, accordintly, be granted seniority and pay fixation. However, he shall not be entitled to any arrears of salary since he has not worked on the said post."

In the above order issued by Hon'ble High Court, the Vice-Chancellor has been pleased to implement the above court order. In compliance of the Hon'ble High Court order dated 14.08.2023 the services of Dr. Ravendra Kumar, Assistant Professor, Department of Chemistry, College of Basic Sciences & Humanities is hereby terminated with immediate effect from this University.
