At the outset the Dean, College of Agriculture welcomed all the members.

1. University Ranking Data 2021:-

The House was informed that the data has been received but still some data yet to be collected.

(Action: Dean College of Agriculture)

2. International Students Data

Dr. K.P. Raverkar, Dean PGS said that total number of foreign students in PG and Ph.D. Program registered as on 01.01.2021 should be rechecked.

(Action: Registrar)

3. Faculty Position

The House was informed by Dean, College of Agriculture that except few data from some colleges regarding faculty position have been received. The prescribed proforma from College of Fisheries has not been received.

(Action: Dean College of F.Sc.)

Dean College of Agriculture informed the House that data regarding revenue generated and net profit earned by the University Farm is not received from Comptroller section. In this context the certificate of revenue generation should also be provided by the comptroller office. Revenue generated as tuition fee deposited by the students must be included in university income and certificate should be given. Point C6 in the University ranking proforma is also require a certificate.

(Action: Comptroller)



4. Research Section in Ranking Proforma:-

Dean College of Agriculture expressed his concern regarding the proof of data should be produced for research productivity, research excellence, extension, radio talk etc.

(Action : D.E.E.)

5. ICT in Extension Services in 2021:-

The Hon'ble Vice-Chancellor suggested that prepare data of approximately 15000 farmers can be considered as registered farmers for advisory services.

(Action: D.E.E.)

6. Pear Recognition:-

It was decided that data regarding awards received by Faculty/Students should be available in the University records. The Hon'ble Vice-Chancellor showed concern regarding less numbers of the awards of faculty and students. He emphasized that faculty and students must be encouraged to apply for awards. Senior faculty should apply for National Fellow in the National level professional societies. Data regarding number of Fellows in professional societies should also be available in university records which is still to be included in university ranking proforma. Dean College of Agriculture requested that students if awarded any fellowship or award must be included for university ranking.

(Action: All Deans/DES/DEE)

## 7. Experience shared by the student/faculty:-

Students visited IRRI under Students Exchange Program shared their experiences. Faculty members visited Romania also shared their experiences and memories with members of UMC.

In the last the Hon'ble Vice-Chancellor emphasized that good working atmosphere should be developed in the university and juniours must be appreciated for their work. The Hon'ble Vice-Chancellor further instructed all Deans/DES for preparation of guidelines for commercialization of Technology developed by the university scientist.
